Charter Cancellation Policy

- Cancellation of a confirmed domestic trip within 24 hours of the scheduled departure will result in a cancellation fee of two flight hours at the quoted rate and all incurred costs.
- Cancellation of a confirmed trip within 48 hours of the scheduled departure will result in a cancellation fee of one flight hour at the quoted rate and all incurred costs.
- Cancellation of a confirmed international trip within 24 hours of the scheduled departure will result in a cancellation fee of 3 flight hours at the quoted rate and all incurred costs
- Cancellation of a confirmed international trip within 48 hours of the scheduled departure will result in a cancellation fee of 2 flight hours at the quoted rate and all incurred costs
